  - (3) Mr. David Bond was appointed as a director of the company on June 16, 2008 and resigned on March 31, 2009.
  - (4) On March 31, 2009, the company entered into a share cancellation/return to treasury agreement with Mr. Bond wherein Mr. Bond agreed to the cancellation and return to the treasury of all but 50,000 share of the common stock of our company held by Mr. Bond.
