#### Item 2.02 Results of Operations and Financial Condition

On May 19, 2016, Stage Stores, Inc. ("we," "our" or "registrant") issued a news release reporting our unaudited financial results for the first quarter of fiscal 2016 and updating our guidance for fiscal 2016.

The news release included "non-GAAP financial measures," as that term is defined by Rule 101 of Regulation G (17 CFR Part 244) and Item 10 of Regulation S-K (17 CFR Part 229). Specifically, the following non-GAAP financial measures were included: (i) adjusted net loss; (ii) adjusted earnings / loss per diluted share; (iii) adjusted gross profit; and (iv) adjusted selling, general and administrative expenses. The non-GAAP financial measures exclude from the most directly comparable financial measure calculated and presented in accordance with accounting principles generally accepted in the United States of America ("GAAP"), the following items: (a) in connection with the consolidation our corporate headquarters and severance charges associated with our workforce reduction initiative, an after-tax charge of approximately \$0.07 million for the first quarter of fiscal 2016, and (b) in connection with our strategic store closures, an after-tax charge of approximately \$0.3 million, or \$0.01 per diluted share, for the first of fiscal 2016 and \$0.4 million, or \$0.01 per diluted share, first quarter of fiscal 2015. The news release posted in the Investor Relations section of our website contains a presentation of the most directly comparable financial measure calculated and presented in accordance with GAAP and a reconciliation of the difference between the non-GAAP financial measures and the most directly comparable financial measures calculated and presented in accordance with GAAP. We believe this supplemental financial information enhances an investor's understanding of our financial performance as it excludes those items which impact comparability of operating trends. The non-GAAP financial information should not be considered in isolation or viewed as a substitute for net income, cash flow from operations or other measures of performance as defined by GAAP. Moreover, non-GAAP financial information as reported by us is not necessarily comparable to other similarly titled measures of other companies due to the potential inconsistencies in the method of presentation and items considered.

Attached as Exhibit 99 to this Form 8-K is a copy of the news release, including information concerning forward-looking statements and factors that may affect our future results.
