As of December 31, 2002, 26,880 shares of Preferred Stock, or 3.4% of the total outstanding shares of Preferred Stock on that date, were held by KSC L.P. and 49,920 shares of Preferred Stock, or 6.3% of the total outstanding shares of Preferred Stock on that date, were held by KSC Ltd.

KSC L.P. may be deemed to have shared voting and dispositive power over the 26,880 shares of Preferred Stock it owns, or 3.4% of the total outstanding shares of Preferred Stock. KSC Ltd. may be deemed to have shared voting and dispositive power over the 49,920 shares of Preferred Stock it owns, or 6.3% of the total outstanding shares of Preferred Stock.

KSA:

Because KSA is the general partner of KSC L.P., pursuant to Rule 13d-1, as of December 31, 2002, KSA may be deemed to be the beneficial owner of 26,880 share of Preferred Stock, or 3.4% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC L.P.

Because of the relationship described above, KSA may be deemed to have shared voting and dispositive power over the 26,880 shares of Preferred Stock, or 3.4% of the total outstanding share of Preferred Stock.

KSCM:

Because KSCM is the investment adviser to KSC Ltd. pursuant to Rule 13d-1, as of December 31, 2002, KSCM may be deemed to be the beneficial owner of 49,920 shares of Preferred Stock, or 6.3% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC Ltd.

Because of the relationship described above, KSCM may be deemed to have shared voting and dispositive power over the 49,920 shares of Preferred Stock, or 6.3% of the total outstanding shares of Preferred Stock.

O. Francis Biondi, Jr.:

Because Mr. Biondi is a managing member of both KSA and KSCM, pursuant to Rule 13d-1, as of December 31, 2002, Mr. Biondi may be deemed to be the beneficial owner of 76,800 shares of Preferred Stock, or 9.7% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC L.P. and KSC Ltd.

Because of the relationship described above, Mr. Biondi may be deemed to have shared voting and dispositive power over an aggregate of 76,800 shares of Preferred Stock, or 9.7% of the total outstanding shares of Preferred Stock, consisting of shares owned by KSC L.P. and KSC Ltd.

Brian J. Higgins:

Because Mr. Higgins is a managing member of both KSA and KSCM, pursuant to Rule 13d-1, as of December 31, 2002, Mr. Higgins may be deemed to be the beneficial owner of 76,800 shares of Preferred Stock, or 9.7% of the total outstanding shares of Preferred Stock on that date, consisting of the shares owned by KSC L.P. and KSC Ltd.

Because of the relationship described above, Mr. Higgins may be deemed to have shared voting and dispositive power over an aggregate of 76,800 shares of Preferred Stock, or 9.7% of the total outstanding shares of Preferred Stock, consisting of shares owned by KSC L.P. and KSC Ltd.

Because of the relationships described above, the Reporting Persons may be deemed to constitute a "group" within the meaning of Rule 13d-5 under the Securities and Exchange Act of 1934, and as such, each member of the group would be deemed to beneficially own, in the aggregate, all of the shares of the Preferred Stock held by members of the group.
