Teachers Advisors, Inc. ( Advisors ) is the investment adviser to three registered investment companies, TIAA-CREF Funds ( Funds ), TIAA-CREF Life Funds ( Life Funds ), and TIAA Separate Account VA-1 ( VA-1 ), as well as one or more separately managed accounts of Advisors (collectively, the Separate Accounts ) and may be deemed to be a beneficial owner of 1,441,404 shares of Issuer s common stock owned by the Funds, Life Funds, VA-1 and the Separate Accounts.
