Item 8.01. Other Events.

Effective as of December 30, 2005, Synergetics USA, Inc. (Registrant) entered into amendments to its existing distribution agreement and existing license agreement with Codman & Shurtleff, Inc. (Codman). Under the existing distribution agreement, dated as of October 1, 2004, as later amended, Codman distributes certain products manufactured by Registrant, including Registrant's Malis® CMC III Biopolar Generator. Under the existing license agreement, dated as of March 23, 1983, as later amended, Codman licenses from Synergetics IP, Inc., Registrant's wholly-owned subsidiary, the Malis® trademark. These agreements were to expire on December 31, 2005. Under the amendments, each agreement's term has been extended until January 6, 2006, while the parties continue to negotiate the terms and conditions of a new distribution agreement and a new license agreement.
